Town Manager Wedemeyer explained this was the second of the required two public hearings and required budget work sessions, all of which were legally posted and published. The proposed budget has been posted for two consecutive weeks in the local news paper and when adopted will go to the Auditor General. The overall budget is 2 million less than the past years; it does include a 3% cola for all employees plus the possible up to 3% merit for all employees on their anniversary date. Council commented good work to all the departments for keeping their expenditures down and major kudus to the manager for all the hard work. There were no citizen's comments.

Town Manager Wedemeyer stated council had heard earlier comments on the proposed adoption of the next fiscal budget, which additionally the proposal had received no comments from the public for or against.

MOTION: Resolution 07-2015 the 2015-2016 Town of Parker FY Budget is approved in

the amount of \$16,296,970, to include the following: Capital Projects \$7,389,996.65, including \$292,002 from the GADA loan, \$5,500,000 from grant funding. The Astro-turf will be funded if total amount is raised by outside entities. Chamber of Commerce funded at \$23,000, Tourism at \$25,000 and \$20,000 to Economic Development, the Community Partners will remain at the same as in FY 2014-2015, the employees will receive a 3%

COLA and up to 3% Merit on their anniversary date

PRESENTATION: Planning and Zoning Issues – David Plunkett

Mr. Plunkett previously provided information for the council both written and via a thumb drive of a past planning and zoning meeting and the last council meeting which pertained to agenda item #2 for them to listen to and read. After the last P & Z meeting he stated he assumed being the committee deigned the text changes the item was done. Council have all stated both the current zoning book and general plan need to be updated. All of council were in agreement, no one wants more boat storage in the residential sections of the town, they are better suited to the industrial areas; what is badly needed is more residential units either houses or apartments. What is permitted compared to what is not was discussed by many council members additionally, they discussed was having a use buffer surrounding the property. Mr. Edwards

stated Mr. Plunkett has been asked twice for a site plan for his upcoming proposal so a permit could be issued; to date nothing has been submitted. As a whole the council agreed it is best to put this request to bed, work on the new general plan and on a new zoning book which would be the best fit for all and to move on.

Public Works Director Edwards explained this was the second visit for council on the request to place a cell tower behind the LaPaz County Public Works out at Parker South. The tower would allow additional broadband for all the governmental facilities within the area and is highly beneficial for all; the style and color of the tower is a unknown at this time added Mr. Edwards. No comments were given by Council

Public Works Director Edwards explained the test amendment change for the public and the council; comments were given by the mayor and council for and against the change request. Town manager added that both the general plan and updates to the zoning book are in the upcoming budget. Overall the agreement for new housing projects rather than the additional storage units was confirmed by the council, but agreed at this time to deny the text amendment change.

Public Works Director Edwards explained the town started late last year holding public hearings to ask the community what the public thought would best serve all the town residents needs if the town acquired funding from the Department of Housing and the CDBG Grant. A new water line to upgrade the existing on the north side of the town was decided upon. Council inquired how many residents would benefit from this project; 24 to 27 households would benefit from the water line project.
