PRESENTATION: C.W. Romo, Chief Parker Police Department

In the absence of Chief Romo Lt. Michael Bailey explained to the Council now the Town of Parker Police Department now has a Fire Arms Instructor, Officer Venegas had attended and completed Firearms/Rifle Instructor school and is an Active Shooter Instructor. During the recent Fall Break at the school district Officer Venegas coordinated an "active shooter" training for Parker Police, LaPaz County Sheriff's Dept., the Quartzsite Police, both CRIT Police and their Fish and Game officers, along with members of ADOT over the course of three days there were involved in simulated "live fire" with the use of blanks; with the local police explorer as volunteers were mocked-up wounded gun shot victims. Officer Venegas was then recognized for his dedication and commitment by the Mayor and Council.

CM R Hartless discussed the town taking over the original contract from LaPaz County back in 2017 and asked how much longer would it be in place for, and what would happen to the jobs if neither continues with the agreement? Did anyone know what the county is planning for the program that serves more of

the county residents that the town's residents. Either way it was agreed the town does receive 5% of the funding for the administration of the intergovernmental agreement.
